
#### 1. Introduction

#### **XML**

Extensible Markup Language (XML) is a markup language that defines a set of rules for encoding documents in a format that is both human-readable and machine-readable. This interface allows businesses and integrators to integrate and retrieve identity data of individuals using XML formatted data over a secure SOAP connection.

#### **SOAP**

Originally defined as Simple Object Access Protocol, is a protocol specification for exchanging structured information in the implementation of web services in computer networks.

This document serves as technical guide to allow 3rd parties to access the PBVerify API Service by means of SOAP web service through a secure HTTPS tunnel.

#### 2. Service Overview

## **Personal Credit Report API**

#### **Function: getPersonalCR**

- a. This API service provide three functions to draw credit bureau related Credit Check information on a South African consumer.
- b. The three report types are as follows:
  - i. Basic report
  - ii. Standard report
  - iii. Premium report
- c. Information required for the use of this API is as follows:
  - i. Username ,Password and MemberKey
  - ii. Consumer Information
    - ID Number (Mandatory)
    - First Name (Mandatory)
    - Second Name (If applicable, otherwise return "none")
    - Third Name (If applicable, otherwise return "none")
    - Last Name (Mandatory)
    - Reason Code (Mandatory)
      - 1. Reason Codes are as follows:

        - b. 2 Fraud Prevention
        - c. 3 Employment
        - d. 4 Book Assessment
        - e. 5 Credit Limit

- Postal Code (If available, otherwise return "Not Available")
- Landline Code (If available, otherwise return "Not Available")
- Landline number (If available, otherwise return "Not Available")
- Work landline number (If available, otherwise return "Not Available")
- Work number (If available, otherwise return "Not Available")
- Mobile Number (If available, otherwise return "Not Available")
- iii. Reference This is used for internal purposes and is a compulsory field.
- iv. Report Type (mandatory field (option of one only))
  - 1. basic report
  - 2. standard report
  - 3. premium report

- E03 Report Type missing or not supported
- E04 Report Creation Error with specific code contact support
- E05 XML Return error contact support
- E06 Report Creation Successful
